Position Overview

The Geriatric Nurse Clinician in the Emergency Department is a registered nurse in an expanded role demonstrating a high level of autonomy and expert skill to formulate clinical decisions and appropriately manage geriatric patients with acute/chronic illness and promote wellness.

The principle responsibilities include utilizing and demonstrating a comprehensive theoretical knowledge base and advance level of clinical competence in caring for elder patients, acting as a resource and serving as a consultant to individuals and groups within the professional community and other hospital/agencies.

Primary Responsibilities

1. Assessment:

- Responsible for completing comprehensive gerontological assessment including active
 medical problems, past medical history, medication, functional assessment, social history,
 bedside physical assessment, cognitive assessment and review of lab/x-ray tests and current
 as well as past health record.
- Conducts geriatric assessment using appropriate screening tools (i.e. mmse Folstien, geriatric
 depression scale, audiology screening) and clinical cognitive and physical assessment.
- Interview patient, family, family physician and community health professionals to gather extensive past and current history.
- Identify high-risk patients for facilitation of appropriate interdisciplinary follow up.

2. Consultation:

- Develop an intervention plan based on identified needs.
- Communicate assessment findings and recommend interventions plan to appropriate physician and/or staff.
- Facilitate referrals to services, programs and agencies as appropriate.
- Facilitate and advance discharge planning process.
- Provide supportive and counselling to patients and family members to decrease inappropriate admission and repeat emergency visits.
- Negotiate for adequate community supports for patients.

3. Collaboration:

- Collaborate with members of interdisciplinary team and community agencies to obtain provide and exchange information related to patient's health care needs.
- Facilitate formal/informal methods to promote geriatric consult referrals.
- Attend team and family conferences to share geriatric consultation impression and recommendations.

• Provide resource expertise for patients' families and interdisciplinary team members in management of geriatric patients (e.g. falls, dementias, incontinence, etc.).

Other Duties

- 1. Capacity Building and Teaching:
 - Provide capacity building services to internal and external GEM stakeholders
 - Provide clinical teaching to students (e.g. nursing students, nurse practitioners, medical residents, etc.).
 - Provide in-services to professional colleagues.
 - Provide formal/informal teaching to patients, families, interdisciplinary team members in the management of geriatric patients.
 - Provide lectures on areas of professional expertise at in hospital workshops and forums.

2. Research:

- Develop, participate in and evaluate research activities.
- Evaluate practice and program to determine effectiveness.
- Critically analyze and incorporate research/evidence into clinical practice.

Others:

- Complete workload measurement statistics and monthly data as required for effective and efficient program operation (e.g. number of referrals, discharges and dispositions).
- Promote timely response in completing consultations.
- Keep abreast of current trends and issues in gerontology.
